ACADEMIC COUNCIL POLICY RECOMMENDATION

F72-1

At its meeting of October 16, 1972, the Academic Council passed the following proposal, as presented by Chairman Weed of the Organization and Government Committee:

(Note: This is submitted in lieu of action of May 8, 1972, which the President disagreed with and which he returned. This recommendation will repeal #F69-17 and amend #S69-23 in order to comply with the rules of the NCAA.)

CONDITIONS CONCERNING MEMBERSHIP

A. The faculty members shall be recommended to the Academic Council by the Committee on Committees of the Academic Council in consultation with the chairman of the Student Council. To establish the Athletics Board, two faculty members shall be appointed for 1-year terms, two for 2-year terms and one for a 3-year term. Thereafter, faculty members shall be appointed for 3-year terms as vacancies arise. Replacements shall be made in the same manner as appointments.

THE CALIFORNIA STATE UNIVERSITY AND COLLEGES

- B. The student voting members shall be designated as follows: A. S. Treasurer,

 A. S. Council member, major sport representative chosen by those athletes,

 minor sport representative chosen by those athletes, and a student-at-large

 which shall be designated through the normal appointive machinery of the

 Associated Students in consultation with the chairman of the Committee on

 Committees of the Academic Council. Initially-three-students-shall-be

 appointed-for-l-year-terms-and-twe-shall-be-appointed-for-2-year-terms.

 Thereafter, students-shall-be-appointed-for-2-year-terms-as-vacancies

 arise--Replacements-shall-be-made-in-the-same-manner-as-appointments.
- C. The Athletic Department shall be represented by the Director of Athletics or his designee. Normally the Presidents of the Alumni Association and of the Spartan Foundation will serve on the committee; however, either may appoint one of the other Executive officers to represent him. The student representative from the athletic teams shall be elected by a process to be determined by the team members and shall serve for one year. No two successive representatives shall be participants in the same sport. The President of the University shall appoint the Administration representative and faculty athletics representative.
- D. A faculty representative shall be chosen from and by the Departments of Physical Education, either men's or women's.
