Statement from Senator Trousdale

Candidate for Chair of Instruction and Student Affairs

Dear Esteemed Colleagues of the SJSU Academic Senate,

My name is Alaric Trousdale and I am honored to have been nominated for the position of chair of the Instruction and Student Affairs Committee of the SJSU Academic Senate. I have served on the ISA committee for the last two years and have had the opportunity in that time to learn about the committee's diverse stakeholders, how it operates, and how important the committee is to supporting both student and faculty success. It has been my sincere pleasure to serve on the Academic Senate as I am committed to the principles of shared governance and to serving our campus community.

I am currently the only staff member serving on the Academic Senate as a representative of the General Unit. My position as Study Abroad Coordinator in the College of International and Extended Studies has provided me with a unique perspective on the structure of our institution and also of the needs of our diverse student body. I am responsible for all of our Spartans studying abroad on exchange at partner institutions for the semester and the academic year, and I also support all of our incoming international exchange students. The Study Abroad office is in a fairly rare position since we routinely work with all other units on campus, from the Registrar to Financial Aid, from GUP and every academic department in our six colleges to University Housing and Student Affairs.

If elected as chair, I would bring to the ISA committee not only a profound commitment to student success, but also a diverse, international perspective and a naturally collaborative and diplomatic approach to problem solving. In my time on the ISA committee I have built strong relationships with my colleagues and I want to continue to support the important work we have done as a team.

Before my career as an international educator, I taught medieval history as an assistant professor in the Oregon State university system and also taught abroad in the United Kingdom, where I earned my Ph.D. and lived for many years. My knowledge of academic processes here at SJSU and also at other institutions - both in the United States and internationally - and my interest in making policies work for all involved makes me a dynamic choice for the chair of ISA. I have a demonstrated interest in where the classroom and broader institutional policies intersect, and I would feel privileged to serve as the chair of the ISA committee, if I was so elected.

Statement from Senator Kenneth B. Peter

Candidate for Chair of the Professional Standards Committee May 2018

I would welcome the opportunity to continue as Chair of the Professional Standards Committee.

I am proud of the record of accomplishments of the Professional Standards Committee under my leadership over the last six years. Here are a few of our accomplishments over that time:

- Weeding of dozens of obsolete policies for which PS is responsible.
- Modernized and consolidated of nine teaching evaluation policies into one clearer document.
- Created an important study that highlighted the critical need to rebuild our declining base
 of permanent faculty. With uncertain budgets and changes in academic leadership
 looming, Professional Standards should continue its advocacy for the rebuilding of our
 faculty base.
- Revised the Emeritus Faculty policy, the GRIF policy, and the Awards policy.
- Drafted and shepherded to passage a complete overhaul of our 17 year old ARTP policy and have continued to "debug" it as it goes into implementation.
- Conducted workshops to prepare the campus for transition to the new RTP policy.
- Updated (after numerous tries!) the SOTE/SOLATE policy.
- Drafted a resolution defending faculty intellectual property from weakening by the system administration.
- Successfully modernized the Chairs and Director's policy—a politically sensitive document that took two years to complete.

Next year RTP issues will continue to be salient as more and more faculty fall under the new RTP policies, and I hope to continue to assist Faculty Affairs and the new Provost as they have questions about the policy, or requests for changes.

The main focus for Professional Standards for next year will be the modernization of our policy on ethics and Professional Responsibility—a document that has fallen into obsolescence and which needs to be reviewed with great sensitivity. We also have begun research into several other important issues related to professional standards, including information ethics and bullying—and would anticipate continuing to explore these issues.

All policy Chairs also serve on the Executive Committee and have a general obligation to serve as Senate leaders. I believe my depth of experience over approximately a quarter century on the Senate and under ten Presidents and nine Provosts has given me a perspective that has been valuable during recent years. I have served as Chair of the Senate, ASCSU Senator, and Chair of

several policy committees, and been a primary author of more than 50 Senate resolutions and policies.

More important, though, than simply serving in a variety of capacities, is my deep seated commitment to collegial shared governance. I have chosen to spend my life at a University rather than in civil service or business because we are governed differently than those other institutions. Well governed universities function with a healthy component of workplace democracy, which strengthens a sense of commitment and community around a shared social mission. That ideal, however, requires a heavy commitment of faculty to university service, and it is in that spirit that I offer my candidacy to chair the Professional Standards committee.

Statement from Senator Roxana Marachi Candidate for Faculty-At-Large Member to the Executive Committee

I am grateful for the opportunity to serve on the Academic Senate at San José State University and am honored to have been nominated for consideration as a Faculty-At-Large member on the Executive Committee.

I believe my participation on the Executive Committee would bring unique and valuable perspectives as my teaching, research, and community engagement keep me on the pulse of many of the most current issues in education policy and practice. While I am laser attuned to education issues locally, my research also extends to state and national initiatives, and allows a rare lens in seeing how challenges in other regions are now taking hold here in California. Topics that I study include the the psychology of learning and motivation, the privatization of public education, and the integration of technology into learning spaces.

Over the past 12 years, I have taught in the Department of Teacher Education and more recently, this past semester joined the faculty in the Doctoral Program in Educational Leadership. Since 2016, I've served as the Education Chair of the San Jose Silicon Valley NAACP and am active in many community initiatives including the Strong Start and School Climate/Leadership Committees at the Santa Clara County Office of Education and the Santa Clara County Juvenile Justice Systems Collaborative. While my initial published research has focused on school climate and integration of violence prevention efforts within the K12 system, I've also seen uncanny parallels in the ways these policies and practices bridge into higher education.

While it may not be apparent now how current technological trends will impact learning in the long run, I believe it's extremely important to pay close attention to nuanced and critical perspectives on the emergence of big data, predictive analytics, machine learning, and artificial intelligence – all trends that are poised to impact not just our work at SJSU, but our lives beyond the campus. I care deeply about sustaining and strengthening the human connection in teaching and learning, and believe that if SJSU is truly going to be a leader in Powering Silicon Valley, that we'll need to be intentional about efforts to strengthen inter-disciplinary perspectives to integrate health, human development, social justice, and ethical practice at the core of innovations.

I humbly ask for your support in voting for me to serve as the Faculty-At-Large member on the Executive Committee and look forward our continued work together.

Statement from Senator Shannon Rose Riley For Candidate for Associate Vice Chair/Chair of Committee on Committees

I am in my 3rd term as a Senator and have served on O&G, Professional Standards, the University Library Board, and as the Faculty-at-Large on the Senate Executive Committee. This past year, I served as the AVC/Chair of Committee on Committees; I am very interested in continuing to serve in that capacity for another year. I enjoy helping with Senate recruitment and feel that I have been effective in my role as AVC given that the majority of seats for next year's committees are in the process of being filled. Statement from Senator Mark Van Selst

Candidate for CSU Statewide Representative to the Executive Committee

I have been one of three statewide senators from SJSU to the academic senate of the CSU since 2002. As one of the three statewide senators from SJSU to the Academic Senate of the CSU I am also a member of the SJSU academic Senate. I am currently serving an SJSU statewide senate term ending in May 2019.

I seek to be the statewide representative to the executive committee (In previous years I have served with the majority of the current and anticipated nominees to the executive). In recent years the role of *Statewide Senate Representative* to the Executive Committee has been determined by the SJSU senate by election (i.e., with multiple nominees). Unusually, in the last year both Senator Lee and I served on the SJSU Senate Executive Committee (*at large* and *statewide* respectively).

At the departmental, college, and university levels my service is broad but has a particular strength in issues around academic affairs (curriculum, GE) and pre-collegiate preparation and transfer. I anticipate remaining visible and active at both SJSU and statewide for the foreseeable future. I envision my service background being of particular use as issues around GE (courtesy of the revisions to EO1100) and Academic Preparation (courtesy of EO1110) continue to occupy a disproportionate amount of campus and system focus.

At the state level, I have chaired the *Academic Affairs*, the *Academic Preparation and Education Programs*, and the *Chancellor's General Education Advisory Committee*. I have also served on the *Executive Committee* of the Academic Senate CSU. I am, or have been, closely involved in a variety of statewide curriculum and transfer/articulation initiatives including implementation of three independent CSU doctoral degrees. I have been the CSU segment lead for various inter-segmental transfer initiatives including the Inter-segmental Major Preparation Articulated Curriculum (IMPAC) project, the Lower Division Transfer Pattern (LDTP) Project, the C-ID course numbering system, and SB 1440 implementation (with a side role as a campus facilitator).
